#### 1. Announcement

The South Hams Motor Club Ltd will organise a National B permit multi use Stage Rally on 18/19<sup>th</sup> MAY 2019 at RRH Portreath, Cornwall.

#### 2. Jurisdiction and Authorisation

Held under the General Regulations of the Motor Sports Association (Motorsport UK) (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions the organising club may issue for the event.

MSA Permit No. TBA

#### 3. Eligibility

The event is open to:

- a) All fully elected members of the organising club
- b) All fully elected members of the member clubs of the ASWMC
- c) All fully elected members of the member clubs of the ACSMC
- d) All fully elected members of the member clubs of the WAMC

#### 4. Entrant/Competitor Eligibility

Competitors are reminded of the requirement to produce valid Competition Licence of the appropriate grade, valid Club Membership cards, Championship Cards (if applicable) and Entrants Licences (if applicable) at Documentation.

#### 5. Vehicle Eligibility

5.1 The event is open to all vehicles complying with Motorsport UK General Regulations for Special Stage Rallying.

5.2 All vehicles must have ready for inspection at signing a valid registration document, valid MOT Certificate (if applicable) and a MSA/Motorsport UK CCLB/Vehicle Passport.

5.3 Vehicles will not be required to be taxed or insured for the public highway.

5.4 Any vehicle with forced induction will have a capacity loading of 70% and this may result in a class change.

5.5 The organisers reserve the right to re-classify any vehicle where they deem it's fair to do so

5.6 All competing vehicles must carry a spare wheel.

5.7 Door Numbers will not be supplied and they will not be on sale at the venue.

5.8. No Incar camera/recording devices or ANY kind will be permitted

9.1 Entries for the event will open on publication on these SRs and close on Wednesday 8<sup>th</sup> May 2019

9.2 The entry fee is £325.00

9.4 Cheques should be made payable to: South Hams Motor Club Limited.

9.5 Entries will still be classed as Provisional on the part payment option of  $\pounds100.00$ . Entries will only be accepted on completed entry form and with full payment. Full payment must be received before the closing date.

9.6 Incomplete entry forms may be returned and deemed as not accepted.

9.7 The **Entries Secretary** to whom all paper entries and cheques (if applicable) must be sent is:

9.8 Entries cancelled in writing up to and including Wednesday 8<sup>th</sup> May will be refunded; any entry cancelled after Wednesday 8<sup>th</sup> May 2019 will be refunded at the organisers' discretion, and if refunded, subject to an administration fee of £30 to cover costs incurred. Caravans are subject to a separate cancellation policy (see later in these SRs at the Accommodation section)

9.9 Entry fees will not be refunded to any entry that fails to start or meet the Noise Scrutineering/Documentation requirements. Any competitor not signed on 30 minutes before their due start time may be excluded without refund and their place may be allocated to a reserve.

- 9.10 Entries are accepted at the discretion of the organisers. The organisers reserve the right to refuse an entry.
- 9.11 The order of starting will be at the organiser's discretion and will be based on information given on the entry form. No discussions will be entered into regarding the starting order of any competitor.
- 9.12 The **MAXIMUM** number of starters for the event is 90 plus 10 reserves.

9.13 The **MINIMUM** entry for the event is 50.

9.14 Should SR 9.13 not be reached the organisers have the right to cancel the event.

9.15 Entries will be refunded in full should the venue be required for military manoeuvres.

9.16 After the closing date should inclement weather or any other situation arise that requires the organisers to cancel parts of, or the whole event for whatever reason, partial refunds MAY be offered at the organisers discretion.

#### 10. Route & Format

10.1 The event will take place wholly at RHH Portreath, Cornwall. The route will be defined in a Road Book using Stage Diagrams that will be issued at Documentation along with Timecards and any additional information.

10.2 On occasions as defined by the Road Book and/or timecards, competitors will be required to do two stages before visiting Service.

10.3 The location of Noise Test, Scrutineering and Documentation will be notified in the finals.

10.4 Ordnance Survey maps will not be needed but may be carried and/or used by competing crews.

10.5 The event will consist of 14 special stages covering over 110 miles on sealed surface roads. There is a 30 yard section over grass used on 7 stages.

Saturday 9 stages SS1-9 approximate total: 57.6 miles Sunday 5 stages SS10-14 approximate total: 57.8 miles

10.6 Arrows will be used to indicate the correct direction at junctions where a change of direction is required.

10.7 Advance warning arrows will be discarded where distances prohibit their safe use.

10.8 At chicanes or other hazards, chevron type marker boards may be used to indicate the correct entry point in accordance with R29.1.1

10.9 Samples of all stage markers and control boards will be available for inspection upon request at Documentation.

10.10 The event will utilise **TARGET TIMING** in accordance with R31.1. All controls will open upon arrival of the 00 car and close 1 minute after the due time of the last car.

10.11 Competitors due time at MTC1 will be notified on Official Notice Board in the HQ at documentation, and due time at MTC3 will be notified on Official Notice Board in the Rally Office at Perran Sands on Saturday and in the paddock area on Sunday.

10.12 At Service In control, competitors will be issued with their due time at the next Service Out Control by a Marshal under the supervision of the Motosports UK Timekeeper.

10.13 In accordance with R40.1.6 and R40.1.7 any crew that misses a stage or control can resume at Service Out controls as the Official Rejoin point. This must not be higher than, or more than 15 places lower than their original seeded position.

10.14 Competitors **WILL** be required to start stages at 30-second intervals.

10.15 It is the responsibility of competing crews to ensure that all time cards are completed correctly and the organisers reserve the right to use whatever means are at their disposal to establish times taken in the event of illegible or disputed times.

10.16 Special Stages will be timed to an accuracy of 1 second by marshals under the supervision of an Motorsports UK Timekeeper.

#### **11. Modifications to the General Regulations**

11.1 The 2019 Regulations of the Motosports UK are modified as follows:

11.2 J5.18 All vehicles may be subject to additional noise tests. Any vehicle failing to meet the requirements of such tests may be subject to immediate withdrawal until eliminated in accordance with R24.8.1. In all cases the decision of the Clerk of the Course, in conjunction with the MSA Environmental Inspector, shall be final.

11.3 R5.4.3: Only the nominated driver shall drive on any special stages.

11.4 R24.4.5: Red Flags WILL BE USED.

11.5 R25.7.2 The starting procedure for Special stages will be via a 'Traffic Light' system. At 15 seconds to go, the **RED LIGHT** will show. At 10 seconds to go, the **RED** and **AMBER LIGHTS** will show. At 5 seconds to go, these will be re placed by an **AMBER CLUSTER**, which will individually extinguish each second 5-4-3-2 -1. At 0 seconds to go the **GREEN LIGHT** will show – this will be the signal to **START.** 

11.6 There will be **NO PENALTY FREE LATENESS** between time controls.

#### 12. Penalties, Results, Ties & Protests

12.1 All penalties will be as R32.1 and R32.2 with specific reference to Chart 32.2A2 (page 334) – not reporting or reporting OTL at a control – 30 minutes penalty per stage.

12.2 Interim results will be displayed on the Official Notice Board and handed out throughout the event.

12.3 Results will be published within one hour of the finish of the event or posted/emailed within 7 days.

12.4 Ties will be resolved in accordance with R40.1.2

12.5 Protests must be made in accordance with C5.1.2 and C5.2.1

13.2 No competitor may win more than 1 award except Spirit of the Rally or the Channel Islands award. The organisers reserve the right to amend the awards list at their discretion.

13.3 To be eligible for the 1<sup>st</sup> SHMC Crew awards competitors must have been fully elected members of SHMC club prior to 1st May 2019 and entered under SHMC.

13.4 Award winning competitors must be present to collect their award and failure to do so **WILL RESULT IN FORFEITURE** of the award. Such forfeiture will not apply to placing in the results.

13.5 All perpetual trophies are property of the organising club, and must be returned safely after 11 months or sooner if requested, in a clean condition.

#### 15. Venue Access & Service

15.1 Competitors are reminded that **ALL** persons connected with their entry are subject to the rules and regulations governing servicing and service personnel. See also SR16

15.2 No Photos or Videos to be taken at ANY TIME whilst at the venue. This includes mobile phones, cameras, drones, "Go Pro" style cameras and <u>your</u> <u>service crew, family and support personnel</u>. Non-compliance could result in exclusion from the event and removal from the venue

15.3 No open fires, BBQs or open flames are to be allowed anywhere on venue, by order of the RAF.

15.4 Servicing will take place in a central location for the entire event .Due to the "Secure Status" of the venue, competitors will **ONLY** be issued with passes for the personnel you enter on your Security Information Sheet.

15.5 Entry to the venue will be restricted to Pass-Holders only and any unauthorised persons found at the venue **WILL BE ARRESTED** by the military authorities and treated as a threat to Venue Security.

#### 15.6 SPECTATORS AND DOGS ARE PROHIBITED AT ALL TIMES.

15.7 Any competitor found servicing in any areas other than the specified Service Area WILL BE EXCLUDED - ALL AREAS OTHER THAN THE SERVICE AREA ARE OUT OF BOUNDS.

15.8 Any person(s) found in areas deemed out of bounds shall cause the entry with which they are associated, or have entered the venue, to be deemed as in contravention of SR 15.3 and SR 15.5, may be subject to penalty (up to and including exclusion).

15.9 In accordance with the Motorsports UK definition of "pump fuel", it is permitted to use of fuel up to but not exceeding that permitted by FIA Appendix J, Article 252, Article 9 (maximum 102 Octane).

15.10 Petrol & Water will not be available at the Service Area.

15.11 Hot food, drink and WC facilities will be available throughout the day at the Service Area.

15.12 There will NOT be a designated re-fuelling area. Competitors are reminded of the requirements under the Health & Safety at Work Act regarding the refuelling of vehicles. All entrants must ensure that all persons connected with their entry have read and understood the following statement:

'Every person participating in this event, whether employed or voluntary, shall take reasonable care for health and safety of themselves or other people who may be affected by his / her acts or omissions during the operation of the event.' Notes for Service Area Best Practice will be issued in the Final Instructions and/or at signing on and **ALL** Service Personnel are required to comply with the conditions within.

ALL Competitors and Service Personnel MUST be present at the Health & Safety Briefing in the paddock at 10:45 on Saturday.

15.13 All servicing will be on tarmac and must be carried out on a **Tarpaulin or similar** which is responsibility of the competitors and not provided by the organisers.

15.14 All spillage must be contained and removed from the site.

15.15 Under 16's are permitted onto the base. However, please ensure they are supervised by an adult at **ALL TIMES.** This permission can be withdrawn by the venue security at any time during the event and you they will be asked

to leave if their actions are deemed to pose a Health and Safety risk to themselves or other competitors or venue users.

15.16 No pushbikes, motorbikes, scooters or pit bikes are allowed on site. No movement of vehicles in the service area except rally cars and officials.

15.17 Excess speed in the opinion of any official in the service area will not be tolerated, with the penalty being upto and including Exclusion from the event.

#### 16. Security and Health & Safety

As Portreath is an active RRH Station we are required to submit names and addresses of everyone entering the base. Please fill in the form provided and send in with your entry or, **by the closing date at the latest**. This should include crew, service personnel, family etc. The correct number of passes will be sent out with the final instructions and these must be produced at the gate.

<u>No pass may mean no entry</u> and this will not be accepted as reason for a refund. The final instructions will include a Health and Safety Brief, and every person entering the venue, WITHOUT EXCEPTION, will sign to confirm they have read the Brief and agree to abide by its contents. With the heightened level of security, Final Instructions will not be mailed out until all names are submitted. There will be NO opportunity to get passes after the closing date.

#### 17. Trophy Rally

17.1 This will run on the Sunday **only** and is available for any crew that is deemed to have retired after final classification of the Saturday results.

17.2 Crews will have the opportunity to compete on all the Sunday stages, SS10 - SS14

17.3 Vehicles will have to be re-scrutineered for conformity.

17.4 Crews will run in their original seeded order or at the discretion of the Clerk of the Course.

17.5 Results will be calculated separately with awards for the first crew overall.

The 2019 TSH will once again use Perran Sands Haven Holiday Park as the overnight venue. The park is approximately a 13 mile drive from the event's venue and has all the facilities you need.
